THE SMALL FARMER CAN FEED HIS FAMILY NUTRITIONALLY IN THE SRA PROGRAM ON THE SAME LAND HE ONCE USED FOR ONLY ONE CROP. THE SRA PROGRAM IS EDUCATIONALLY FOCUSED AND PARTNERS WITH UNIVERSITIES, OTHER NGOS, AND GOVERNMENT ORGANIZATIONS. IN 2011, SRA EXPANDED OPERATIONS TO INCLUDE AN OFFICE IN KENYA.
